Educational Activities with Italian and Foreign Scholars

Themes and problems in the history of ideas (24 hours)

Teaching addresses topics capable of cross-linking theories, concepts, ethical-anthropological, scientific, socio-environmental and aesthetic problems; doctoral students are required to have (a) adequate language skills for source investigation and (b) specific analytical and critical processing skills. Papers are expected from by doctoral students with collegial discussion and comparison, and papers by Italian and foreign scholars; languages of the course may be: Italian, French, English.

TITLE: ECOSYSTEMS. Critical thinking, political ecology, and social diagnosis; Responsible: Prof. Daniela Angelucci and Prof. Dario Gentili

Philosophical-scientific thinking (6 hours)

Teaching aims to provide highly specialized skills for the investigation of fundamental epistemological issues and problems, scientific (e.g., natural sciences, social sciences, sciences of mind and language); doctoral students are required to have (a) adequate skills linguistics for the analysis of sources; (b) specific skills exegetical and critical skills. Papers by doctoral students with collegial discussion and discussion and interventions by Italian and foreign scholars are expected; languages of the course may be: Italian, English.

Issues and problems in the history of ideas (27 hours)

The course covers the selection of one or more concepts and/or themes on textual bases classics relevant to doctoral students' research directions. This year the chosen theme is: habit. To consolidate rigorous philological research and an aptitude for methodologically grounded critical
